

MEMORANDUM OF ASSOCIATION OF THE AAB ITA WELFARE SOCIETY (AIWS)

Article no.1. NAME OF THE SOCIETY:- The name of the Society shall AAB ITA WELFARE SOCIETY and AIWS in short form.

Article no 2. REGISTERED OFFICE:- Registered office of the Society shall be remain in Arunachal Pradesh and at present it is at the following address:-

P.O./P.S.Nirjuli/Itanagar

Dist. :- Papum Pare

State:- Arunachal Pradesh.

Article no 3. AIMS AND OBJECTIVES:- The aims and objectives for which the society is establish are as under:

- i) To create a sense of brotherhood, co-operation, mutual harmony, love and affection amongst the members of the society and also amongst the general public.
- ii). To organize seminar on social justice, education and economic upliftment to raise legal demands and fundamental rights provided by 'Constitution of India'.
- iii). The society shall open found, establish promote, set up run maintain, assist, support, and broadly take up the reasonable or effective Schemes of Age Care; Health care; Arts & Craft; Agriculture; Animal welfare; wild life's; Children; Women Development; cities and Urban; Culture & Heritage; Disability; horticulture; Education; Forest & Environment; Science & Technology; S.C. and S.T.; Human Resource; Rural Development; Panchayat; Wast management; Sports; other social and welfare activities as the society may deem fit and proper.
- iv). To found, open and or help the community development programmes/ activities and also construct and develop the community halls, Sochalays, Charitable Dispensaries, libraries, and other buildings/ Institutions for use and welfare of the general public.
- v). To establish, maintains or grant aid for the establishment, construction, and maintenance of roads, Khadanja, Parks, Sewerage etc.
- vi). To take up effective but reasonable and lawful steps for the eradication of social evils such as Dowry system, wastage of money in various functions, use of intoxication drugs, Child Marriage (Bal Vivah) and Child Labour etc.
- vii) To take up effective, reasonable and lawful steps for the solution of problems relating to members of the Society or relating to general publics.
- viii). To approach the competent court/courts to safeguard the rights of the general public and for the public interests from time to time as the society may deem fit and proper.
- ix). To accept donations, grants presents gifts and other offering in the shape of movable and or immovable properties for the attainment of the Aims and Objects of the Society.
- x). To purchase/acquire the land and or the building in the name of the society for the upliftment of and fulfillment of the Aims and objective of the society.
- xi) To do such other things/ acts/ activities which are necessary which may be incidental or conductive to the attainment of any of the objects of the Society.
- xii) All the incomes, earnings, movable or immovable properties of the Society shall be solely utilized and applied towards the promotion of its Aims and objects only as set forth in the memorandum of the Society and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus profits or in only manner whatsoever to the present or the past members of the more of the present and the past members. No member of the Society shall have any personal claim on any movable or immovable properties of the society or make any profits, whatsoever by virtue of this membership.
